The LE-1 and LE-3 licence holders may make transaction in respect of RE-2, RE-11, RE-12 and RE-13 for trial purpose.

It is proposed to run the module on trial basis for use of all the LE-1 and LE-3 Licence holders for a period up-to 30th November 2018, so as to get them acquainted with the system and to get their feedback & suggestions for further fine tuning of the module prior to the Phase-I GO-LIVE as schedule in December, 2018. - 1. The SETT Trial URL is: https://eservices.peso.gov.in:8080/PesoIdentity/account/login.
- 2. To login in to the SETT Trial system, kindly use existing ERS's User ID and Password.
- 3. This SETT Trial system is purely for TRIAL purpose and will not have any impact on the existing ERS activities like RE-2, RE-7, RE-11, RE-12 and RE-13 etc. during the trial period.
- 4. For all the entries under RE-2, RE-7, RE-11, RE-12 and RE-13 etc. on the SETT Trial system will be maintained by PESO on separate servers and will not have any impact on stock of any magazine. The trial data will be removed by PESO after the trail is over.
- 5. Regular activities of ERS like RE-2, RE-7, RE-11, RE-12 and RE-13 etc. will continue through ERS only.
